19 **WHEREAS**, the Contractor entered into an agreement with the City on **April 28, 2010** to
20 provide municipal street improvements to Veterans Administration Medical Center (VAMC)
21 Infrastructure Improvements.

22 **WHEREAS**, the City has determined that the Contractor will be required to comply with the
23 Community Development Block Grant (CDBG) procedures; and

24 **WHEREAS**, it is agreed that the Contractor does not waive his rights to claim additional
25 compensation; and

26 **THEREFORE IT IS HEREBY AGREED:**

27 **The Contractor shall comply with the document: CDBG COMPLIANCE**
28 **PROVISIONS FOR CONSTRUCTION CONTRACTS, as shown in the attachment to**
29 **this contract amendment; and**

30 Both parties to this amendment hereby reaffirm the validity of all other provisions of original
31 Agreement dated **April 28, 2010**, save the above changes.
