PERSONALLY CAME AND APPEARED:

THE GENTILLY DEVELOPMENT DISTRICT, a state created community development district, whose principal place of business is 2500 General Meyer Avenue, Bldg 415, New Orleans, LA 70114, represented herein by Gretchen Bradford, Executive Director, hereinafter referred to as **"Donor"**

And

THE CITY OF NEW ORLEANS, a municipal subdivision of the State of Louisiana, whose principal place of business is 1300 Perdido Street, New Orleans, LA 70112, represented herein by LaToya Cantrell, its Mayor, hereinafter referred to as **"Donee"**

Donor, who declares that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, they do by these presents, irrevocably, give, grant, transfer and donate unto Donee, any and all rights, title and interest in and to the hereinafter described property, with all legal warranties and with full substitution and subrogation in and to all the rights and actions of warranty which Donor has or may have against all preceding vendors and owners, and Donee hereby appearing for the purpose of accepting same, accepts said donation for Donee, its successors and assigns, and acknowledges the delivery and possession of the following described property (the **"Property"**), to-wit:

- **\$150,000.00** to be used for the construction of a walking path on the Elysian Fields Avenue neutral ground within the Gentilly Development District boundaries.

The parties hereto waive the production of conveyance and mortgage certificates in connection with this donation and understand that neither have a title or tax examination been performed and do hereby relieve and release the undersigned notaries, from any and all liability and responsibility in connection therewith.

Upon execution of the Donation, Donee assumes complete responsibility for the maintenance and upkeep of the Property. Donee assumes full responsibility for any damage or injury to any person or property occurring on said Property.

The Property is accepted, donated and conveyed in its "as is" physical condition. Donee expressly waives all warranties as to the Property herein donated, whether implied by this or any other writing or representation, as well as all warranties provided by law. This waiver applies to all warranties of any nature, express or implied, including without limitation warranties of fitness for a particular purpose, or of merchantability, or otherwise. Donee has examined the Property thoroughly and is fully satisfied with its condition.

The Donor acknowledges and certifies that the Donor does not, as a result of this Donation, have any expectation of benefit or special treatment with regard to contracts, potential contracts, or other matters with the City of New Orleans, or any of its agencies, boards, commissions, or public benefit corporations.

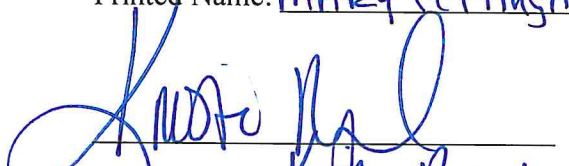
