**CONTRACT**  
**CITY OF NEW ORLEANS**

**LAMARQUE FORD, INC**  
**BID PROPOSAL NO.: 199**  
**FORD MOTOR COMPANY OEM REPAIR PARTS**

**THIS CONTRACT** (the “**Contract**”) is made and entered into, by and between the City of New Orleans, represented by LaToya Cantrell, Mayor (the “**City**”), and Lamarque Ford, Inc., represented Ronald M. Lamarque, President (the “**Contractor**”). This Contract is effective as of December 17, 2019.

**WHEREAS**, the Contractor submitted the lowest responsive bid in response to the City’s Invitation to Bid for Bid Proposal No. 199 dated October 18, 2019, seeking a contractor to provide Ford Motor Company OEM Repair Parts; and

**WHEREAS**, the Contractor, whose office is located at 3101 Williams Blvd., Kenner, LA 70065, is qualified; and, has the necessary expertise, and

**WHEREAS**, the City desires to award the Contract to the Contractor.

**NOW THEREFORE**, the City grants and confirms to the Contractor the contract to provide Ford Motor Company OEM Repair Parts to the City under Bid Proposal No.2297-01677, and the City and the Contractor, for good and valuable consideration, agree as follows:

**I. THE CONTRACTOR’S OBLIGATIONS.**

The Contractor will perform all obligations of the Contractor, and be subject to all terms and conditions set forth, in this Contract and in the following documents that are incorporated fully into this Contract: the Invitation to Bid for Bid Proposal No. 199 dated October 18, 2019; the Contractor’s Bid dated November 7, 2019 (the “**Bid**”).

**II. THE CITY’S OBLIGATIONS.**

The City will pay the Contractor at the rates set forth in the Contractor’s Bid for the satisfactory performance of this Contract and will perform all obligations of the City, and be subject to all terms and conditions set forth, in this Contract and any incorporated documents.

**III. ADDITIONAL PROVISIONS.**

**A. Convicted Felon Statement.** The Contractor complies with City Code § 2-8(c) and no principal, member, or officer of the Contractor has, within the preceding five years, been convicted of, or pled guilty to, a felony under state or federal statutes for embezzlement, theft of public funds, bribery, or falsification or destruction of public records.

**B. Non-Solicitation Statement.** The Contractor has not employed or retained any company or person, other than a bona fide employee working solely for it, to solicit or secure this Contract. The Contractor has not paid or agreed to pay any person, other than a bona fide employee working for it, any fee, commission, percentage, gift, or any other consideration contingent upon or resulting from this Contract.

**C. Non-Waiver.** The failure of either party to insist upon strict compliance with any provision of this Contract, to enforce any right or to seek any remedy upon discovery of any default

or breach of the other party at such time as the initial discovery of the existence of such noncompliance, right, default or breach shall not affect or constitute a waiver of either party's right to insist upon such compliance, exercise such right or seek such remedy with respect to that default or breach or any prior contemporaneous or subsequent default or breach.

**D. Entire Agreement.** This Contract, including all incorporated documents, constitutes the final and complete agreement and understanding between the parties. All prior and contemporaneous agreements and understandings, whether oral or written, are superseded by this Contract and are without effect to vary or alter any terms or conditions of this Contract.

**IN WITNESS WHEREOF**, the City and the Contractor, through their duly authorized representatives, execute this Contract.

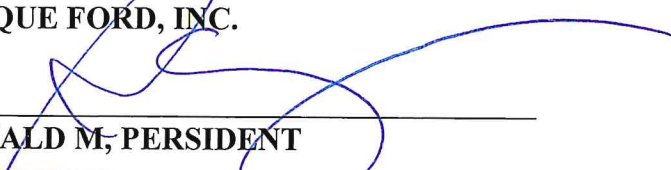
