AMENDMENT NO. 3 TO AGREEMENT

BETWEEN

THE CITY OF NEW ORLEANS

AND

MHC SOFTWARE, LLC.

THIS THIRD AMENDMENT (the "**Amendment**") is entered into by and between the City of New Orleans, represented by LaToya Cantrell, Mayor (the "**City**"), and MHC Software, LLC., represented by Zachary Bloss, Corporate Controller (the "**Contractor**"). The City and the Contractor are sometimes collectively referred to as the "**Parties**." The Amendment is effective as of the date of execution by the City (the "**Effective Date**").

RECITALS

WHEREAS, on November 15, 2017, the City and the Contractor entered into an agreement for software to provide document management capabilities integrated with Infor Cloud Suite Financials (the "**Agreement**");

WHEREAS, the City and the Contractor amended the Agreement to ensure continuity of Services; and

WHEREAS, the City and the Contractor, each having the authority to do so, now desire to enter this Amendment to ensure continuity of services by increasing compensation.

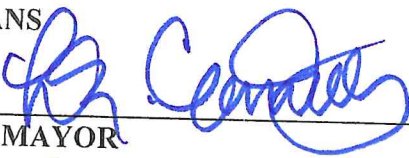
NOW THEREFORE, for good and valuable consideration, the City and the Contractor amend the Agreements follows:

1. **Compensation.** The compensation described in Article IV Section B of the Agreement is increased by \$31,574.12 to a total amount not to exceed \$380,825.30.
2. **Convicted Felon Statement.** The Contractor swears that it complies with City Code §2-8(c). No Contractor principal, member, or officer has, within the preceding five years, been convicted of, or pled guilty to, a felony under state or federal statutes for embezzlement, theft of public funds, bribery, or falsification or destruction of public records.
3. **Non-Solicitation Statement.** The Contractor swears that it has not employed or retained any company or person, other than a bona fide employee working solely for it, to solicit or secure this Amendment. The Contractor has not paid or agreed to pay any person, other than a bona fide employee working for it, any fee, commission, percentage, gift, or any other consideration contingent upon or resulting from this Amendment.
4. **Prior Terms Binding.** Except as otherwise provided by this Amendment, the terms and conditions of the Agreement remain in full force and effect.
5. **Electronic Signature and Delivery.** The Parties agree that a manually signed copy of this Amendment and any other document(s) attached to this Amendment delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Amendment. No legally binding obligation shall be created with respect to a party until such party has delivered or caused to be delivered a manually signed copy of this Amendment.

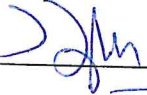

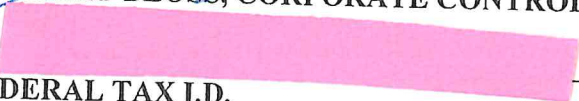
